Protection is provided to IEC specification EN55024; Immunity Characteristics for Continuous and Transient, Conducted and Radiated Disturbances. Electrostatic discharge (ESD) protection is also provided. For maximum effectiveness, the grounding tab of the CLESP must be securely connected to the frame ground of the installation.

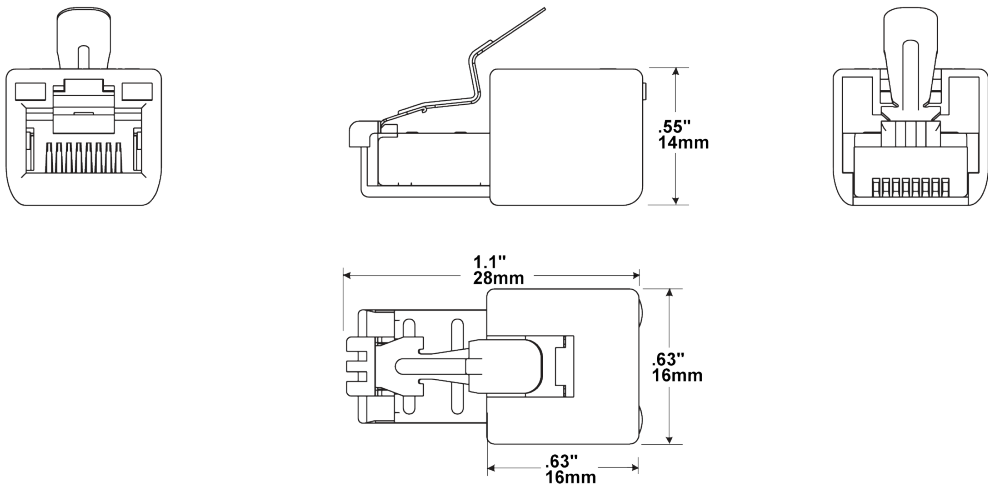

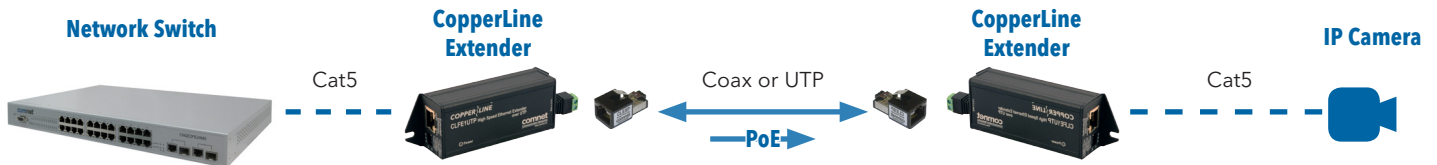
